Toni Bankston, LCSW, BACS currently serves as the Executive Director of the Baton Rouge Children’s Advocacy Center. She is a Louisiana Master ACES trainer and serves on the Governor’s Advisory Board for Human Trafficking. A native of Baton Rouge, she has been a child and family psychotherapist for 30 years in the area of trauma and resiliency. She is a co-author of professional journal articles focusing on work with children impacted by trauma and disaster. Toni serves as needed with the Center for Mind-Body Medicine, D.C. as a member of the U.S. Faculty and Global Trauma Relief Team in Haiti, Israel and Gaza, Sonoma (wildfire disaster), Houston (Gustav), and Broward County (Stoneman Douglas school shooting). In this capacity she has worked to develop programs and train other healthcare professionals in trauma recovery, with an emphasis on programs for youth and secondary stress in their caregivers and providers. Locally, her work in Louisiana has included bringing wellness programs to disadvantaged populations, including the street homeless in Baton Rouge, children in urban school-based settings, and working with Coastal residents in the aftermath of Hurricanes Katrina, Rita, Gustav, Isaac and the Horizon BP Oil Spill. She has also served as Adjunct Faculty at the LSU School of Social Work.

Workshop Summary: This workshop will offer background information regarding a modern understanding of childhood trauma based on science and research. It will explore the guiding principles of trauma-informed approaches and trauma-specific interventions whether the participant is working as an individual provider or part of a larger system. It will outline why this knowledge and approach is essential for everyone to have access to regardless of the profession within they work. The participants will be offered several examples of successful integration of Trauma-Informed Models in different settings both locally and elsewhere in the United States.

Joseph A. Prokop, Jr., JD, LLM, is an attorney practicing in Baton Rouge and is a board certified specialist in estate planning and administration, with a focus on elder law, disability law, and mental health law. He served as the Mental Health Liaison Officer for East Baton Rouge Parish for almost ten (10) years, and has filed thousands of Petitions for Judicial Commitment in East Baton Rouge Parish and surrounding parishes over the years. He works closely with mental health professionals, families and the courts to assist people who suffer from mental illnesses with obtaining the treatment and care that they need. Mr. Prokop is a frequent state and national lecturer on issues affecting the elderly and disabled, interdictions, and judicial commitments. He is a member of the Louisiana State Bar Association and the National Academy of Elder Law Attorneys. He has been honored by Super Lawyers and Best Lawyers in America on numerous occasions. Mr. Prokop is the author of Louisiana Successions (3rd ed. LexisNexis 2018).

Workshop Summary: This workshop will provide a refresher course on the Mental Health Law, discuss the newly-implemented Assistive Outpatient Treatment (AOT) law, and cover the other legal tools available to assist people suffering from mental illnesses. The written materials are designed to serve as a reference manual in your practice and include the law, forms, and other helpful resources. The adult Mental Health Law will be reviewed, including formal and informal voluntary admissions, noncontested admissions, Orders of Protective Custody (OPC), Physician Emergency Certificates (PEC), Coroner’s Emergency Certificates (CEC), and the Judicial Commitment process. Similarities and differences between juvenile and adult Judicial Commitments, the purpose of the Assistive Outpatient Treat (AOT) law and the AOT commitment requirements and process will be discussed. Full Interdiction, a limited Interdiction, and a Continuing Tutorship will be compared, as well as circumstances when interdiction is not appropriate.
